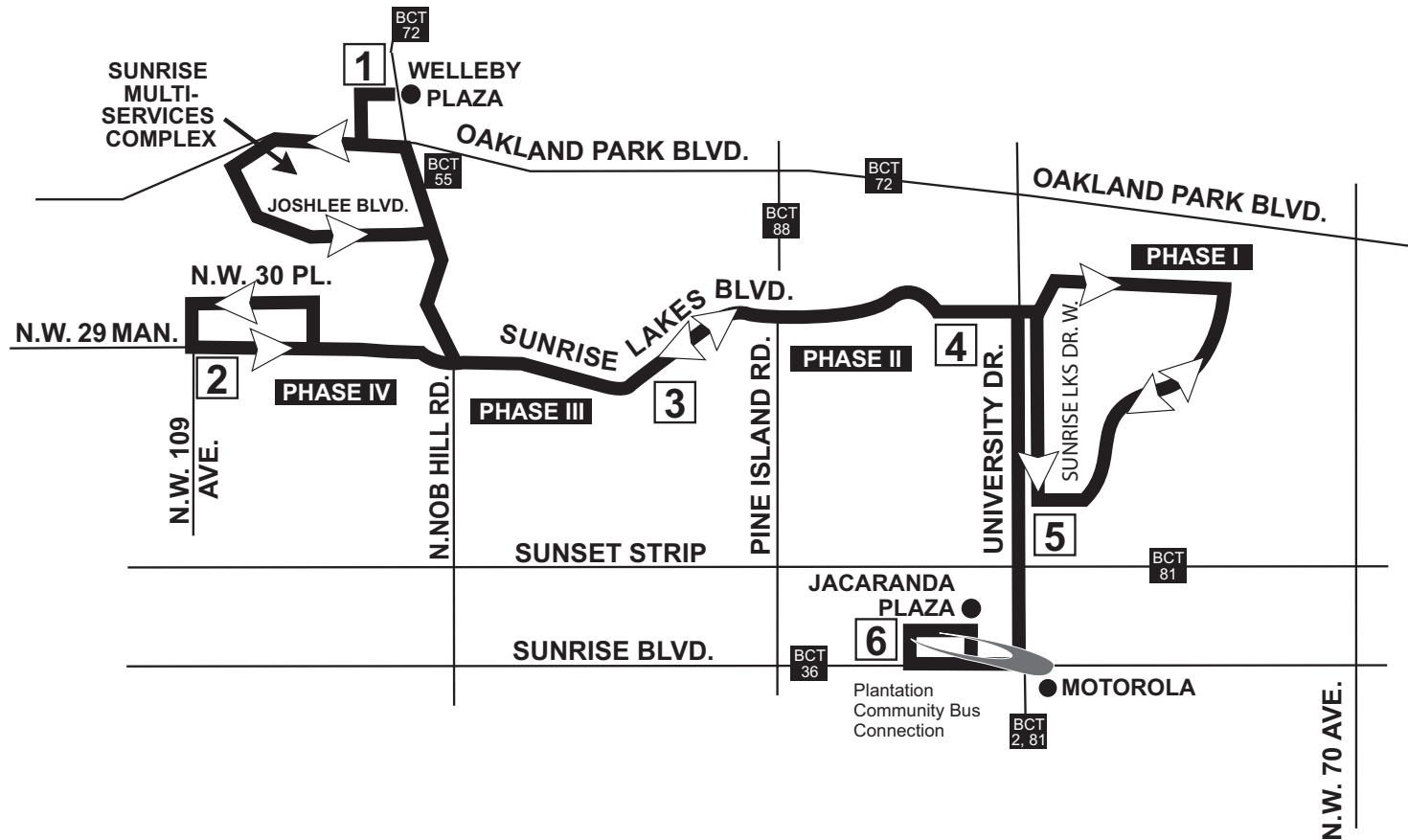

Hours of Operation

Monday through Friday
6:30 a.m. - 7:10 p.m.

Service operates as close to schedule as possible, although traffic conditions may cause bus to arrive slightly early or late. Please allow yourself enough time when traveling.

These routes will not operate when a hurricane warning has been issued.

This service is provided by Broward County Transit to increase the number of destinations within the city limits that can be reached through public transit.

The 56 Shuttle is designed to operate in conjunction with connections to BCT routes 2, 36, 55, University Breeze, 81 and connects to the City of Plantation Community Bus.

There is no charge for using the 56 Shuttle. Riders making connections to BCT buses must pay the appropriate fares.
