## Welcome to the Miramar Community Bus Service

The City of Miramar, in partnership with Broward County Transit (BCT), provides community bus transportation service to enable travel throughout the City of Miramar and connects to BCT routes for travel throughout Broward County. The Miramar Community Bus services connects with BCT routes 2, 5, 17, 18, 28, 441 *Breeze* and University *Breeze*.

Other Miramar Community Bus routes connect at the Town Center. The Miramar Community Bus is air conditioned, with bike racks, and wheelchair accessible in accordance with the Americans with Disabilities Act (ADA).

### Bus Stops

Buses stop at designated bus stops and stop only if passengers are visible at the bus stop. Please do not ask the driver to deviate from the route.

### Hours of Operation

**Monday - Friday  
7:00 am - 7:00 pm**

Please refer to the timetable on the reverse side for times and destinations. Buses operate as close to schedule as possible, although traffic conditions may cause the bus to arrive slightly early or late. Please allow yourself enough time when traveling.

This route will not operate when a hurricane warning has been issued.

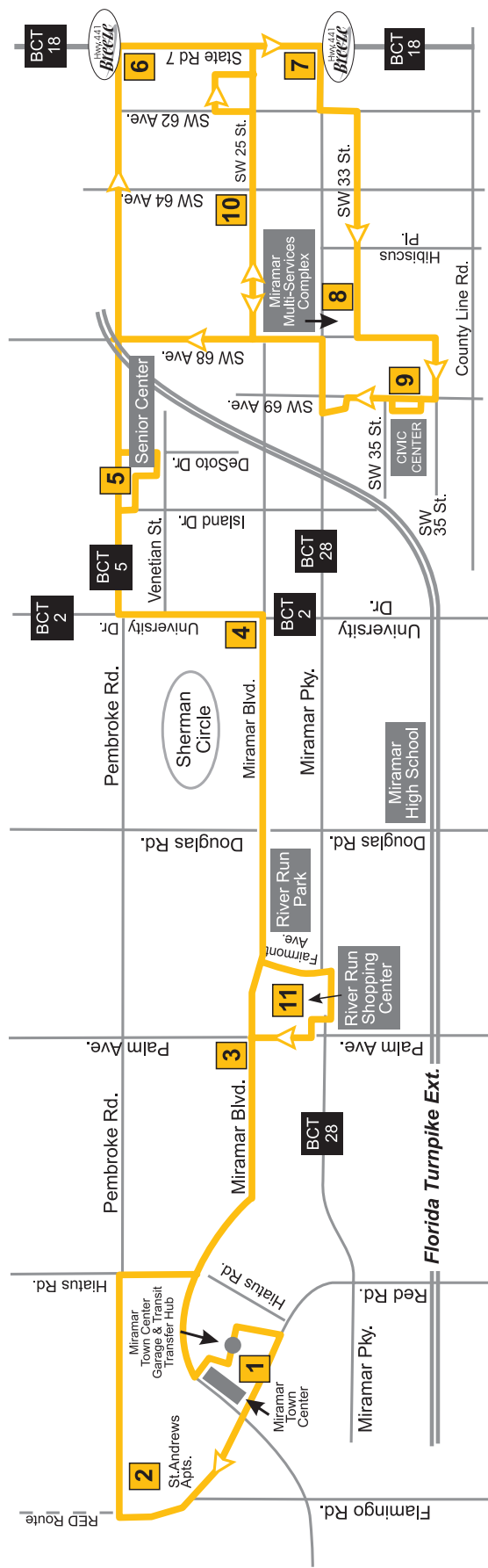
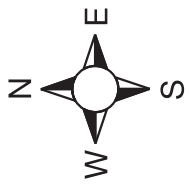
#### PROTECTIONS OF TITLE VI OF THE CIVIL RIGHTS ACT OF 1964 AS AMENDED
